



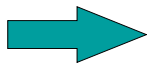

Age Groups based on competitor's age as of December 31, 2017.

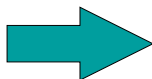

DEADLINE: Entry form completed online by **6:00pm April 9**. **Team check** postmarked by **April 10**. Late entries pay double entry fee. Corrections after roster verification deadline \$10 per athlete, \$20 week of the meet. Please make every effort to submit accurate and timely registrations.

REFUNDS: There will be no refunds after April 9 without a doctors note.
